- I acknowledge that any changes to registration details (e.g. postal address, phone number, ownership) must be made in writing to Council within 7 days of the change occurring
- My dog is not a restricted breed (i.e. Dogo Argentino, Fila Brasileiro, Japanese Tosa or of the type commonly known as 'American Pit Bull Terrier' or 'Pit Bull Terrier') or any crossbreed thereof
- I acknowledge that I am over 18 years of age and understand I am now responsible for the animal/s listed and am liable for any fees, charges, penalties, restrictions, conditions, fencing/enclosure requirements, and all ongoing registration responsibilities
- I confirm the property where the animal is kept is not a vacant allotment, i.e., there is currently an occupied residence on the property, and the property has a suitable enclosure and/or adequate fencing to prevent my animal(s) from escaping
- I acknowledge that the registration period is from the 1 November to 31 October and requires an annual renewal payment
- I acknowledge that Council reserves the right to refuse registration due to non-compliance with Council's Local Laws and compliance action may commence
