## **G/1. MAYORAL STATEMENT OF CURRENT ISSUES**

I would like to start with the National Local Roads and Transport and Infrastructure Congress held in Western Australia recently and thank you Councillor Simon McClintock and Councillor Michelle Wagner for attending the conference as well. Roads are very important, and it was raised again with me this morning how important roads are in our community, and in terms of local government, one of the biggest assets that we manage. Attending the National Local Roads and Transport and Infrastructure Congress is very important to make sure we hear firsthand, not just from councillors but also officers right around the country to see what improvements there are, what efficiencies can be gained and how we can make our roads safer in Queensland and in Australia.

We had the Santos GLNG Mayor's Carols and I want to thank all of the volunteers and organisers of the Mayor's Carols and everyone who attended. Somewhere between 5,000 and 7,000 people attended the Mayor's Carols at the Gladstone Ports Corporation (GPC) Parklands which is a fantastic venue but we may be getting to the point where we are out growing that. I remember as a child we had the carols in the Tondoon Botanic Gardens and I think even at Barney Point but we've had the carols for a very long time at the GPC Marina Parklands and the stage is fantastic. Our amazing team of the Gladstone Entertainment Convention Centre (GECC) do a fantastic job putting that on in terms of sound, audio and lighting but the volunteers are the ones who organise the event overall. I'd like to thank all the volunteers who organised the event, everyone involved, especially the schools who attended. We have had lots of carols right across the region, not just in Gladstone. I thank all the volunteers who have organised those as well.

On Saturday 7 December 2024 we hosted the Boyne Tannum Community Forum which was a perfect opportunity for us to explain in detail the relocation of the Boyne Tannum Aquatic Recreation Centre to the new location in Arthur Street in Boyne Island. A fantastic new facility will be built there and I'm looking forward to seeing that project continuing.

The Gladstone Ulysses Club Toy Run was held on Saturday at the same time and thank you Cr Wagner for attending and representing me at that very special event. The Martin Hanson Memorial Art Awards Artist Talks was held and thank you Councillor Mellissa Holzheimer for attending that one for us. And a number of councillors attended the Zonta Orange Breakfast saying no to violence against women and no to family violence in the Gladstone Region.

On Tuesday 10 December 2024 was the official opening of the new nurse lead walk-in clinic and thank you Councillor Natalia Muszkat for attending that. It is a fantastic facility for the Gladstone Region opening in the valley and it's a free facility.

On Thursday 12 December 2024 the Evolved Cape Class Patrol vessels were commissioned in Darwin and one was named the HMAS Cape Capricorn, named after Cape Capricorn on Curtis Island. This is as a result of us writing to the Chief of Navy a number of years ago and requesting that HMAS Gladstone 3 be considered, but at the same time that they consider naming one of these new Patrol vessels after something appropriate to our region as we have HMAS Gladstone dry docked and on display thanks to the Gladstone Maritime Museum at East Shores and I think it's an appropriate name for the Gladstone Region to be honoured with HMAS Cape Capricorn.

Central Queensland University held their graduation ceremony and thank you Cr McClintock for attending and we had the Calliope Community Forum as well.

Upcoming in the Gladstone Region is the Trainees and Apprentices Queensland Awards night on Thursday 19 December 2024. This weekend there are several communities across the region hosting markets including Agnes Water and Seventeen Seventy, Captain Creek and the Boyne Valley. Head to Council's website for further information. The New Years Eve party will be held at the GPC Marina Parklands again from 5pm until 12am on Tuesday 31 December 2024.

I would like to acknowledge 20 years of service for Councillor Glenn Churchill, who was acknowledged at the Local Government Association of Queensland Annual Conference. Congratulations Cr Churchill.

Councillor Leanne Patrick mentioned that it has been a very busy year for 2024 and wished everyone a very Merry Christmas and a happy and safe New Year.

Councillor Michelle Wagner mentioned that she had the pleasure of attending the National Local Roads, Transport and Infrastructure Congress and provided the following report:

*"I had the honour of attending the 2024 National Local Roads, Transport and Infrastructure Congress conference with Councillor Simon McClintock and Mayor Matt Burnett, who attended as president of the Australian Local Government Association.*

*A total of 220 local government leaders, engineering and works staff from across Australia gathered in Margaret River, Western Australia, between 3 and 4 December 2024 for the 2024 National Local Roads, Transport and Infrastructure Congress. It was a wonderful venue and the Wadandi and Pilbelmen Peoples were acknowledged as traditional custodians of the lands on which the congress met, and respects were paid to elders' past, present and emerging. A highlight was the Welcome to Country, which was the best I have ever experienced, and it was evident from signage, conference facilities and interactions that the traditional owners and council have a very strong connection and relationship, which was quite inspiring.*

*This year's congress included a significant focus on road safety. Congress delegates acknowledged that local governments manage more than 75% of Australia's road network and have a key role to play in addressing Australia's unacceptable national road toll. One of the biggest messages was that speed does kill and other statistics supported that and we also saw plenty of examples where speed reductions of even 10kms were saving lives and I think looking at the statistics that we have in our region, I think there are some learnings for us and some discussions hopefully down the track.*

*Delegates acknowledged the importance of prioritising road safety in infrastructure investments and discussed opportunities to deliver safer roads in regional and urban settings. Sustainable funding is a significant barrier, and ALGA promised to continue to advocate for more federal support for councils to improve the condition, safety, and productivity of Australia's road network.*

*Several Federal politicians addressed the conference, including Minister for Local Government, the Honourable Kristy McBain, and Shadow Minister for Infrastructure, Transport and Regional Development Senator the Honourable Bridget McKenzie.*

*This year's congress included sessions on improving freight productivity, decarbonising Australia's transport sector, water management, regional airports, addressing the housing crisis, renewable energy transition, the circular economy, and active transport and electric vehicle trends. The event also covered effective asset management, which is vital to the broad range of services and functions delivered by councils.*

*Margaret River's infrastructure and conference venue were truly a credit to the foresight of Shire of Augusta Margaret River Council. Thanks again to Council and my colleagues for sending us to the conference. There were a lot of learnings and hopefully there will be a lot of sharing's to happen as a result of going to the conference."*

Councillor Glenn Churchill referenced a comment made by Councillor Kahn Goodluck earlier in the meeting regarding a 'city crier' and mentioned the benefits of a 'city crier' are being an excellent way to get people to stop, pay attention, understand and be a great advocate to ensure that they are receiving important messages right across the city and the region.

Cr Churchill mentioned the Gladstone Performing Arts Company (GPAC) production of 'Robin Hood and the Babes in the Woods' held over the weekend. Cr Churchill noted that he had the opportunity to do the official opening and thanked the wonderfully talented cast and crew on their production. Cr Churchill acknowledged that there is a significant amount of talent within the Gladstone Region and highlighted GPAC's contribution to the cultural entertainment and recreational vibrancy of the Gladstone Region. Cr Churchill noted that it's not only the performing artists, but the shows, the rehearsals, the costumes, the makeup and the social glue that brings them together. Cr Churchill congratulated Hannah Waddell, the director and stage manager, Kerry Birt, the executive producer and many others adding to the vibrancy and the large cast and crew that were there to make sure that it was a great delivery. Cr Churchill highlighted that the cast and crew come from many different backgrounds including teaching, mentoring, engineering, administration, dentistry, hospitality, community transport and even our own Council officers. Cr Churchill noted that it was a successful show with well over 700 tickets sold and he looks forward to their next production and to GPAC finding a permanent home for the future.

Although it sometimes goes unnoticed by the community, we absolutely respect you, each and every one of you and thank you for your hard work and I wish you a very Merry Christmas."*
